

## Vacancies for independent United Nations experts of the Human Rights Council, with extensive professional experience in human rights

*Those appointed serve in their personal capacities. They are not United Nations staff members, they are not based in the United Nations offices in Geneva or at another United Nations location, and they do not receive salary or other financial compensation, except for travel expenses and daily subsistence allowance of "experts on mission".*

*The mandates for each session are listed alphabetically. Additional appointments may need to be added during the cycle in case of unforeseen vacancies or if the Human Rights Council creates new special procedure mandates. Members of Expert Mechanisms (EMRIP and EMRTD) are not special procedures, although they are appointed in the same way as special procedure mandate holders.*
